Sponsorship	Any payment or provision of any other financial benefit (other than from the Council) made or provided within the last 12 months in respect of expenses incurred by a member in carrying out duties as a member, or towards election expenses or that of a member's spouse/civil partner, or person with whom they live.									
3. Securities	Any beneficial interest in securities of a body which has a place of business or land in the Parish of Boxford and either the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, or one hundredth of the total issued share capital of any class of shares issued or that of the member's spouse/civil partner or person with whom they live.									
4. Contracts	or. that of the member's spouse/civil partner or person with whom partner or person with whom they live.									
5a Land	Any beneficial interest in land within the Parish of Boxford (excluding any easement, or right in or over land which does not carry the right to occupy or receive income), or that of a members's spouse/civil partner, or person with whom they live.									
5b Licences	Any licence (alone or jointly with others) to occupy land in the Parish of Boxford for a month or longer or that of a member's spouse/civi partner, or a person with whom they are living.									
5c Corporate Tenancies	Any tenancy where the Council is the landlord & the tenant is a body in which the member has a beneficial interest or of that of a member's spouse/civil partner or person with whom they are living.									
6a Other membership	Membership of any body where the member is in a position of general control or management and to which a member has been appointed or nominated by the Council.									
6b	Membership of any body exercising functions of a public nature or where the member is in a position of general control or management.									
6c	Membership of any body directed to charitable purposes or where the member is in a position of general control or management									
6d	Membership of any body whose principle purposes include the influence of public opinion or policy (including any party or trade union) or where the member is in a position of general control or management.
