Planning application received for comment - 20/02472/FUL - Coxedd Farm, Westbrook, RG20 8DL	
Proposal: Full planning permission for the conversion of the existing southern barn into a C3 residential	
dwelling, with associated residential curtilage, parking and landscaping, together with the demolition and	
removal of the northern barn and smaller ancillary buildings elsewhere within the site.	
Councillors reviewed the plans and raised several concerns in regard to the change of use of the land and	
what the longer-term plans are to house the cattle. Some concern was raised that a further application	
could follow to create a new cattle barn to replace this one. Also, all agreed that further consideration	
should be made for surface water, there is frequent surface water at this end of Westbrook, all agreed	
these needs to be acknowledged and addresses appropriately. Further concerns were raised on the design	
the property – it was agreed that this is a sensitive site beside the river and within the AONB so the	
conversion should be a sympathetic one. The proposal seemed harsh and of an industrial rather than	
agricultural nature. Councillors believed that the proposal should include more traditional materials to	
keep in line with the nature and history of parish. The Rambler Association comment on the website was	
noted, all agreed that the minor relocation of the footpath slightly further up the field would be of benefit.	
Cllr. Thompson and Clerk to discuss with neighbouring properties to check if they have any further input	PT
on the design that the PC should consider (i.e. overlooking windows etc). Clerk to report back to WBC.	SY
